In the letter second read above, the Director of Medical Education is permitted to exercise control over the 94 Vacant posts be attached to the nearest Medical College Hospital (posts already sanctioned vide G.O.(Ms).No.32, Health and Family welfare, dated: 4.2.2014) subject to condition that they should be diverted or deputed to parent Government Head Quarters Hospitals twice a week or as and when required, to meet the needs of public accessing district Hospitals in the 13 Non- Medical College District Head Quarters Hospitals.

2.In the letter 3rd read above, the Director medical Education has submitted the proposal for distributing the 94 super specialist posts to various Medical and Surgical higher specialities in the Medical College Hospitals, Now, she has requested the Government to issue order to distribute the above 94 posts to the Government Medical College Hospitals under the control of Directorate of Medical Education and to fill up these posts by conducting a Transfer /posting counseling for Medical Officers with suitable Qualifications already in service as per seniority and non – service post Graduate student who have completed their courses in August 2016.

3.The Government have carefully examined the proposal of Director of Medical Education and the Government out of the 105 posts sanctioned in G.O.(Ms).No.32, Health and Family welfare, 4.2.2014, distribute the 94 posts to the Medical college

I am directed to invite attention to the G.O. first cited wherein among others Super specialist Posts were sanctioned to District Head Quarters Hospitals, Out of the 105 posts sanctioned , 94 posts are lying vacant.

2. In the circumstances stated in the references 2&3 cited and to utilize the services of the Super Specialists in the Directorate of Medical Education side to serve the needy people, the following orders be Issued:

- i) The Super Specialist posts sanctioned in G.O first cited be attached to the nearest Medical College Hospital and the Director of Medical Education is permitted to exercise control over the above posts, subject to condition that they should be diverted or deputed to parent Government Head Quarters Hospital twice a week or as and when required, to meet the needs of Public accessing district hospitals in the 13 Non-Medical college District Head Quarters Hospitals.

ii) Director of Medical Education be permitted to fill up the above posts with willing hands and also utilize the Non-Service Specialist after exhausting the service candidates.

iii) The above posts be designed as teaching posts. *

iv) Salary will be drawn under regular head.

v) They will continue to work towards strengthening services in the District Hospitals which are being upgraded to the level of Medical College Hospital by rendering all assistance.
