As per the ref. no:18 cited,

The following criteria is applicable for revised rate of hiring charges from 01.08.2016.

- 1) **The hiring charges are enhanced only in Nagapattinam, Ramnad and The Nilgiris districts where qualified obstetricians & anaesthetists are in deficit.**
- 2) **The same enhancement will also be applicable for special areas i.e., to all the Hill areas where the staff are eligible to avail hill area allowance.**

3) For remaining districts the existing guidelines already issued by this office letter no:2270/SHS/P/2013 dt:04.12.2013 is applicable.
